ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur, the 18-10-2024

eCF No.565802/I/774339/2024 Consequent upon the approval of Hon'ble Cabinet in its meeting held on 8th October 2024 and in partial modification of the earlier Govt. notification issued vide no.RDM-12011(17)/5/2022-LR-REV-R&DM/94 (e-fileNo234314) dated 11th November, 2022, the Governor of Assam is pleased to review MB 2.0 cases pending for clarification w.e.f. 19th October 2024 along with the services of Mission Basundhara 3.0. as per following criteria:

1. Only those cases will be made available to apply which were not rejected due to reasons given in **Annexure – A** (enclosed).
2. Further, in compelling cases other than as mentioned in point no 1 above, upon receipt of review application, the District Commissioner can make a request and Director of Land Records & Survey etc. can decide whether the application can be reviewed or not.
3. While reviewing, applicants can:
 - i. submit additional documents, if any, supporting in favour of acceptance of the application.
 - ii. edit dag number, if wrongly entered earlier.
 - iii. add joint applicants name if any.
4. While reviewing MB 2.0 cases pending for clarification, the three-generation domicile requirement for SC/ST/Tea Tribe/Ex- Tea Tribe/ Adivasi/ Gorkha Communities will be relaxed to allow more such applicants to get the MB 2.0 services.
5. Further, while reviewing MB 2.0 cases pending for clarification, the three-generation domicile requirement will be relaxed for MB 2.0 applicants having genuine refugee certificates of a date prior to March 25, 1971.

For review of MB 2.0 cases, a user fee of Rs. 50/- in rural area and Rs. 100/- in urban area per application will be levied.

Land Not Settleable	Applied for land is in Riverine Area.
Land Not Settleable	Applied for land is a VGR/PGR and not a Khas Land.
Land Not Settleable	Applied for land is a Forest Land (RF/PRF)
Land Not Settleable	Applied for land is situated in Char area, which is excluded from the purview of Mission Basundhara 2.0
Land Not Settleable	Applied for land is already allotted to Govt. organization/Corporation/PSU/Central Govt.
Land Not Settleable	Applied for land is already reserved for Government or Public Purpose.
Land Not Settleable	Applied for land falls under declared wetland.
Land Not Settleable	Applied for land is in Roadside Reserve.

Applicant Ineligibility issues	Repeat application by same applicant in the same Dag for the same service.
Applicant Ineligibility issues	Applicant already owns land in excess of the permissible limit of Seven Bighas for Agricultural purposes and One Bighas for Homestead.
Applicant Ineligibility issues	Primary means of livelihood of the applicant is not found to be Agriculture.
Possession Related issues	Possession of land is disputed
